

## END USER LICENSE AGREEMENT

Please read this End-User License Agreement ("Agreement") carefully before clicking the "I Agree" button, downloading or using ThorApps application or online service ("Application").

By clicking the "I Agree" button, downloading or using the Application, you are agreeing to be bound by the terms and conditions of this Agreement.

This Agreement is a legal agreement between you (either an individual or a single entity) and Bear Entrepreneurial Group P/L trading as ThorApps and it governs your use of the Application made available to you by Bear Entrepreneurial Group P/L trading as ThorApps.

If you do not agree to the terms of this Agreement, do not click on the "I Agree" button and do not download or use the Application.

The Application is licensed, not sold, to you by Bear Entrepreneurial Group P/L trading as ThorApps for use strictly in accordance with the terms of this Agreement.

### **1. License**

Bear Entrepreneurial Group P/L trading as ThorApps grants you a revocable, non-exclusive, non-transferable, limited license to download, install and use the Application strictly in accordance with the terms of this Agreement.

Restrictions

You agree not to, and you will not permit others to:

- license, sell, rent, lease, assign, distribute, transmit, host, outsource, disclose or otherwise commercially exploit the Application or make the Application available to any third party.
- modify, make derivative works of, disassemble, decrypt, reverse compile or reverse engineer any part of the Application.
- remove, alter or obscure any proprietary notice (including any notice of copyright or trademark) of Bear Entrepreneurial Group P/L trading as ThorApps or its affiliates, partners, suppliers or the licensors of the Application.

## **2. Intellectual Property**

The Application, including without limitation all copyrights, patents, trademarks, trade secrets and other intellectual property rights are, and shall remain, the sole and exclusive property of Bear Entrepreneurial Group P/L trading as ThorApps.

## **3. Your Suggestions**

## **5. Updates to Application**

Updates may modify or delete certain features and/or functionalities of the Application. You agree that Bear Entrepreneurial Group P/L trading as ThorApps has no obligation to

- (i) provide any Updates, or
- (ii) continue to provide or enable any particular features and/or functionalities of the Application to you.

You further agree that all Updates will be

- (i) deemed to constitute an integral part of the Application, and
- (ii) subject to the terms and conditions of this Agreement.

## **6. Third-Party Services**

The Application may display, include or make available third-party content (including data, information, applications and other products services) or provide links to third-party websites or services ("Third-Party Services").

You acknowledge and agree that Bear Entrepreneurial Group P/L trading as ThorApps shall not be responsible for any Third-Party Services, including their accuracy, completeness, timeliness, validity, copyright compliance, legality, decency, quality or any other aspect thereof. Bear Entrepreneurial Group P/L trading as ThorApps does not assume and shall not have any liability or responsibility to you or any other person or entity for any Third-Party Services.

Third-Party Services and links thereto are provided solely as a convenience to you and you access and use them entirely at your own risk and subject to such third parties' terms and conditions.

## **7. Privacy Policy**

Bear Entrepreneurial Group P/L trading as ThorApps collects, stores, maintains, and shares information about you in accordance with its Privacy Policy, which is available at [www.thorapps.com/privacy](http://www.thorapps.com/privacy). By accepting this Agreement, you acknowledge that you hereby agree and consent to the terms and conditions of our Privacy Policy.

## **8. Term and Termination**

This Agreement shall remain in effect until terminated by you or Bear Entrepreneurial Group P/L trading as ThorApps.

Bear Entrepreneurial Group P/L trading as ThorApps may, in its sole discretion, at any time and for any or no reason, suspend or terminate this Agreement with or without prior notice.

This Agreement will terminate immediately, without prior notice from Bear Entrepreneurial Group P/L trading as ThorApps, in the event that you fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting the Application and all copies thereof from your mobile device or from your computer.

Upon termination of this Agreement, you shall cease all use of the Application and delete all copies of the Application from your mobile device or from your computer.

Termination of this Agreement will not limit any of Bear Entrepreneurial Group P/L trading as ThorApps's rights or remedies at law or in equity in case of breach by you (during the term of this Agreement) of any of your obligations under the present Agreement.

## 9. Indemnification

You agree to indemnify and hold Bear Entrepreneurial Group P/L trading as ThorApps and its parents, subsidiaries, affiliates, officers, employees, agents, partners and licensors (if any) harmless from any claim or demand, including reasonable attorneys' fees, due to or arising out of your:

- (a) use of the Application;
- (b) violation of this Agreement or any law or regulation; or
- (c) violation of any right of a third party.

## 10. No Warranties

The Application is provided to you "AS IS" and "AS AVAILABLE" and with all faults and defects without warranty of any kind. Except as provided herein, the failure to exercise a right or to require performance of an obligation under this Agreement shall not effect a party's ability to exercise such right or require such performance at any time thereafter nor shall be the waiver of a breach constitute waiver of any subsequent breach.

## **14. Amendments to this Agreement**

Bear Entrepreneurial Group P/L trading as ThorApps reserves the right, at its sole discretion, to modify or replace this Agreement at any time. If a revision is material we will provide at least 30 days' notice prior to any new terms taking effect. What constitutes a material change will be determined at our sole discretion.

### **15. Governing Law**

The laws of South Australia, Australia, excluding its conflicts of law rules, shall govern this Agreement and your use of the Application. Your use of the Application may also be subject to other local, state, national, or international laws.
